# **UEFISCDI** is the main funding agency for higher education, research, development and innovation in Romania



### 2016 and 2017 National RDI Plan calls

**25 calls** for human resources, applied & basic research, institutional performance, awards for excellence in research

8.086 project proposals submitted

- 1.953 funded projects
- 5.901 awards for excellence in research

### ACT – call 2018 – Eranet rules

- **1.000.000** euro budget
- Maximum funding per awarded project :
  - $\in 0.25$  million(if the project is coordinated by a Romanian institution)
  - $\in 0.20$  million (if the Romanian institution (s) is (are) partner(s))
- **Eligible costs:** 
  - Personnel;
  - subcontracted parts should not be core/substantial parts of the project work;
  - Travel expenses;
  - costs.
