- 🌐 Continuous Submission (no specific deadline for submission)
- 🌐 RDA Europe 4.0 covers APC for papers submitted up to July 15th 2020
- 🌐 The papers have to be [submitted](#) following the Journal [focus and scope](#), [authors guidelines](#) and [editorial policy](#).
- 🌐 The Special Collection title (Research Data Alliance Results) must be indicated in the Cover Letter accompanying the submission
- 🌐 Editorial Board is composed by RDA Europe 4.0 members (CNR)
- 🌐 Papers will undergo peer review by field experts



Journal Policy – practicalities

- 🌐 **DATASET:** Authors are encouraged to publish their data in recommended repositories. For a list of generic and subject specific repositories that meet our peer review criteria, see [here](#).

If you are submitting an articles that includes or refers to a data set or source code there must be an associated DOI. This DOI can be obtained by submitting the relevant data to a repository such as [Zenodo](#). Data Science Journal is an open access journal and so we expect that all resources related to articles published in the journal to also be open access.



Journal Policy – practicalities

- **FUNDING INFORMATION:** Should the research have received a funding grant then the grant provider and grant number should be detailed.
 - in order to be supported by the RDA Europe 4.0 project for the **APC payment**, authors must state in the funding information:

«This paper was supported by the RDA Europe 4.0 project that has received funding from the European Union’s Horizon 2020 research and innovation programme under grant agreement No 777388.»

***NB!** Please note that in the submission process you are requested to provide both Funding information as well as the acknowledgements. Please make sure the funding information above is clearly listed including the grant agreement number. To follow we suggest a few acknowledgement statements that you are free to adapt to your specific case, especially if part of a more extensive acknowledgements statement.*



Journal Policy – practicalities

ACKNOWLEDGEMENTS: Any acknowledgements must be headed and in a separate paragraph, placed after the main text but before the reference list.

- Specific acknowledgements – if the work and paper are related to RDA EU grants
 - **RDA EU Node support:**
«This work was partially supported by/developed within the activities of the (Country) RDA Node»
 - **RDA EU Ambassadors programme:**
« This work has been produced with the support of the RDA Europe Ambassador programme.»
 - **RDA EU Adoption grants:**
« This work has been produced with the support of the RDA Europe Adoption grants.»
- Generic acknowledgements of RDA related work - if relevant to research work and paper
«This work was developed as part of the Research Data Alliance (RDA) ‘WG/IG’ entitled ‘long name (short name)’, and we acknowledge the support provided by the RDA community and structures»; <https://rd-alliance.org/about-rda/communication-kit>





Types of submissions

- **Research articles** must describe the outcomes and application of unpublished original research. These should make a substantial contribution to knowledge and understanding in the subject matter and should be supported by relevant figures and tabulated data. Research articles should be no more than 8,000 words in length. Data and software supporting the research should be formally cited and available through a trusted repository.
- **Practice papers** should report upon or critique a specific "happening" such as a release of a major study or other notable occurrence related to the journal focus. Authors interested in submitting a practice paper should discuss the content with the editor before submitting a manuscript. Practice papers should describe the finished outputs of a project, or the procedures in operation in an established data system. Practice papers should be no longer than 3,000 words in length.



Types of submissions

-  **Review articles** can cover topics such as current controversies, the current “state of the art” or the historical development of studies as well as issues of regional or temporal focus. Papers should critically engage with the relevant body of extant literature. Review articles should be no longer than 3,000 words in length.
-  **Essays** cover topics and controversies of interest to the community and aim to stimulate discussion and debate. Essays may be provocative and less focused on reporting original research work but should still consist of original thoughts and ideas. Essays should be no longer than 3,000 words in length.



Collection contents

- 21 papers submitted so far
 - 8 accepted & published
 - 4 papers rejected + 1 to be resubmitted ... see next slide
 - 8 papers under review

Rejected Papers so far

- Poor quality / implementation, eg research questions and results not clearly highlighted, paper structure confusing, no methodology
- Misuse of paper typology
