



Research Programme Area (PAO2)

The Research Programme has as main objective the development of knowledge based on research.

The total Programme Budget is 47.058.824 euro, representing:

- 40.000.000 euro: financial contribution of the EEA & Norwegian Grants;
- 7.058.824 euro: co-financing from the national budget.

Thematic areas:

- Energy
- Environment
- Health
- Social Sciences and humanities, including gender studies and social inclusion studies
- ICT
- Biotechnology

Conditionalities:

No less than 10% of the total eligible expenditure of the programme shall be dedicated to projects falling primarily under the key topic "Roma inclusion and empowerment".

In the final list of projects receiving funding under the thematic area "Social Sciences and humanities, including gender studies and social inclusion studies", gender studies and social inclusion studies are reflected.

Research projects shall include dedicated action exploring the potential for further joint applications between partners from Romania and the Donor State (s) to EU framework programme calls and other international funding sources.

Programme outputs:

- Enhanced performance of Romanian research internationally throught 2 call for proposals and one Small Grant Scheme (SGS) adressed to Romanian applicants Romanian institutions representing Romanian candidates who have received a favourable rating from a previous ERC evaluation (minimum score B in the first or second stage);
- Enhanced collaboration between Beneficiary and Donor State entities involved in the programme through Mobilities Grants and organising workshops on the thematic areas having as goal the sharing experience and good practices, diseminating the project results.
