



IHI call 3 (single stage call)

- Topic 1: Screening platform and biomarkers for prediction and prevention of diseases of unmet public health need
- **Topic 2**: Patient-generated evidence to improve outcomes, support decision making, and accelerate innovation
- **Topic 3**: Combining hospital interventional approaches to improve patient outcomes and increase hospital efficiency
- **Topic 4**: Strengthening the European translational research ecosystem for advanced therapy medicinal products (ATMPs) for rare diseases
- **Topic 5**: Digital health technologies for the prevention and personalised management of mental disorders and their long-term health consequences

IHI call 4 (two stage call)

- **Topic 1**: Expanding translational knowledge in minipigs: a path to reduce and replace non-human primates in non-clinical safety assessment
- Topic 2: Patient-centric blood sample collection to enable decentralised clinical trials and improve access to healthcare

2023 I ACTION GRANTS

Action grants

Call for proposals to support:

- a) access to medical devices for cross-border health threats (HERA);
- b) prevention of NCDs in the area of chronic respiratory diseases;
- c) prevention of NCDs: mental health actions in particular to support vulnerable population groups (migrants, refugees, Roma people and displaced people from Ukraine);
- d) mental health challenges for cancer patients and survivors;
- e) prevention of NCDs in the area of dementia and other neurological disorders;
- f) implementation of the strategic agenda for medical ionising radiation applications: organisation of clinical audit campaigns;
- g) safety and quality of new substances of human origin (breast milk, faecal microbiota transplants);
- h) facilitating organ paired exchange;
- orphan medical devices, in particular targeting paediatric patients.

Tips

- Read background documents (implementation plan, strategic plan for HE etc)
- Link proposal up the chain to a policy, missions
- Even more important to look at where your expertise can help solve a problem/challenge (NOT where can you find funding for your existing project), you are the supplier here
- Consortium composition
 - Who is Challenge owners?
 - From project outputs to outcomes
- Start now, early is better
- Talk with your network, your friends
- Ask for help
- Join, and be active in, partnerships (or make friends with someone who is)
- Learn to write more concisely
